# **Silverlake Received “Best Of The Best” Award 2013 from Forbes Asia**

- Debt less than 75% of shareholders’ equity and
- A trading history of at least 1 year.

The final list of 200 exceptional small and medium sized companies represents the top 1.3% of the category. SAL is the only SGX-listed company out of the 22 companies classified under the Software & Services industry in the final list.

The prestigious award reflects SAL’s growth potential and recognises our contribution in helping major organisations address the challenges in the digital economy.
